EA members MUST present their current membership card – LEG members will be verified via club’s data base

Note: LEGs members are covered for public liability insurance only under the EA Club Insurance policy.

There is no personal accident cover for non EA members.

When you participate in Equestrian activities, you are reminded that there exists potential, notwithstanding all safety guards, for a participant to sustain injury. All participants must therefore prepare themselves by having a commitment to training and a high level of fitness. As a measure of your EA’s support to members, coaches and officials, EA has arranged insurance cover as set out in the EA Affiliated Clubs Insurance Programme and for your benefit and risk protection. In addition to these policies all participants and officials may, and are encouraged, to take out EA, Direct Membership, private health insurance, life insurance and ‘Top Up’ cover over and above the insurance cover specifications defined in said brochure, particularly in relation to ‘loss of Income’.

LEGs temporary membership entitles the participant to be covered under the EA Equine Liability Insurance Policy only. This means, if the participant becomes legally liable to pay damages arising out of accidental bodily injury to any person and/or accidental property damage, the Insurer will indemnify the participant subject to the Limit of Indemnity specified in the Schedule subject to the policy terms and conditions.
